The minutes of the June meeting were read by Secretary Andrew Scott. Necessary corrections were made. Motion to accept the minutes as corrected was made by Chris Granger and seconded by John Hicks. Motion carried.

A report was made by RE Phil Wells regarding the "Weekend Memberships" for non-members as currently instated for racers by SCCA National and as projected for Solo in 2008. It is anticipated that for next season SCCA will add an additional \$15 fee for non-members to participate in Solo events with that amount to be discounted if the non-member joins within a specified time period.

Race Report--no club races. However, Bruce Domeck and David Baughman participated in the vintage races at Mid-Ohio. Bruce won the Formula Atlantic class. Dave was less fortunate as he lost a motor on Saturday and, after replacing it, lost another motor on Sunday---a difficult and expensive weekend for David. Undaunted, he is preparing for a future vintage race.

Solo Audit Sheets--we are currently out and need to get more printed. This is not an SCCA item. Erik Mohn will get more printed.

Erik Mohn reported that the club needs a Timing and Scoring clinic to train more members in the use of the equipment. The consensus was to move forward and set a future date for the clinic. No date is set at this time

Eric Brown asked about Kentucky Region hosting another Solo Safety Steward school. If there is enough interest, this will be done after the current season.

Ken Daugherty made the motion to adjourn which was seconded by Mike Spence. The motion carried and the meeting was adjourned.

# RE Lease.....

As the election for club officers and board members for 2008 approaches, I feel compelled to say a few words on that topic. Kentucky Region has approximately 200 members but only a small group of active ones. As you can see in the article on page one, only 17 showed up for people the striping/stenciling of the lot at Papa John's, and only 14 of those were members. While I know that some members may have had obligations that conflicted with that specific date, the plain truth is that it's only a small corps of dedicated members that continue to do EVERYTHING! They not only plan and execute events and projects but they also carry the heavy burden of governing the region.

As I consider the above, several thoughts come to mind. First of all, the leadership of this club should be in the hands of those who care, so when you look at the upcoming ballot please vote for those candidates that are actively involved. those who come to events and contribute in a positive way. Consider too, that as of this writing, we have one candidate for RE and six for the three open Board positions but no one for the positions of Secretary, Treasurer, or Activities Chairman.

I strongly feel that the future of Kentucky Region depends on others stepping up, especially the younger members, to fill some of the roles previously occupied by the "senior" group. The "graying" of the SCCA is a common topic in general, and our local region is no exception as many of our most active members are over 50 years of age. When these members inevitably "burn out" (or worse), what will happen to the region is obvious: our schedule

will dwindle to only a few events per year or worse yet, cease to exist.

If you want the club to experience continued success, it is imperative that you contact any of the members of the nomination committee (Geoff Hale, Bruce Domeck, or Mike Spence) to run for an office. I hope some of you will care enough to do so; the fate of Kentucky Region lies in YOUR hands.

On another topic, at the July Board meeting, it was unanimously approved that the chairmen of Kentucky Region events and the various chiefs of those events must have Kentucky Region as their region of record. This is in no way meant as an insult to associate members from neighboring regions as they have been helpful in many ways, but it is time for our membership to accept the responsibility of those duties.

And lastly, on August 9, 2007, Kentucky Region was approved for participation in the Junior Kart Program for ages 8-15 (8-11 and 12-15) so we can now accept entries for junior karts at events held at Papa John's Cardinal Stadium or Ft. Knox. Our UPS site is not approved for either adult or junior karts.
